### **Ticketing Commences at St. John's International Airport**

*Ticketing in effect July 1<sup>st</sup>, 2019*

**ST. JOHN'S, NL, Monday, July 1, 2019** – St. John's International Airport Authority announced today that due to safety and security purposes, violators in "No Parking" or "No Parking Except Under Permit" zones at the Airport, will be ticketed pursuant to the Government of Canada's *Contraventions Act*, effective **today, Monday, July 1<sup>st</sup>, 2019**. The Airport Authority wishes to advise that any vehicle parked contrary to these regulations may also be removed at the owner's expense.

"We're committed to ensuring the safety and welfare of all employees, visitors, and the travelling public while on Airport property. We focus on safety and security in everything we do and ticketing at the Airport will mitigate curbside congestion and overall safety concerns," said Dan Pinsent, Manager, Security and Operational Response, St. John's International Airport Authority. "We have many options for parking, including a Cell Phone Waiting Lot with free parking, and seven pre-pay machines so visitors can avail of the express lanes upon exiting."

There are four parking options available to accommodate all needs of those parking at the Airport:

**Cell Phone Waiting Lot**

Free

Free parking with complimentary Wi-Fi. Designed for those waiting for a call from arriving passengers. When passenger arrives, they can then proceed to the Terminal Building.

**Short-Term Parking**

Per half hour or part thereof: \$2.00

No daily maximum

Designed for the quick "in and out" of the terminal in two hours or less.

**Long-Term Parking**

Per half hour or part thereof: \$2.00

Maximum daily rate (24 hours): \$16.00

Per Week (7 calendar days): \$80.00

Gone for a day, a week, or a month? Long-term parking is the solution for you. Parking is intended for more than two hours with no reservations required or restrictions on your length of stay.

**Gold Pass Parking**

Monthly fee: \$120.00 + HST (requires a minimum 6-month contract)

The ultimate time-saver convenience for the frequent flyer. Located in close proximity to the Arrivals Area of the Terminal Building, access to this lot is granted with a swipe card.

Pre-pay machines are available for those visiting the Airport and enables the use of the Express Lanes upon exiting. There are seven pre-pay stations available in the Arrivals Hall; airline check-in counters, and the covered walkway in the Short-term parking lot. Once payment is made, visitors have 20 minutes to exit the parking lot. Charges will be applied beyond this time.
